### NOMENCLATURE SECTION

The Nomenclature section will be held in the central campus main building of the Consejo Superior de Investigaciones Científicas (CSIC) at Calle de Serrano 117, Madrid, from July 15 to 19, 2024, the week preceding the main sessions of the IBC.
